




Figure 1. Turn on transient peak voltage




Figure 2. Test circuit




Figure 3. Turn off switching characteristic




Figure 4. Reverse Current vs. Junction Temperature




Figure 5. Average Forward Current vs. Ambient Temperature




Figure 6. Forward Current vs. Forward Voltage




Figure 7. Reverse Recovery Charge vs. Forward Current




Figure 8. Reverse Recovery Time for IRM vs. Forward Current Rate of Change






Figure 9. Reverse Recovery Current vs. Forward Current Rate of Change

Figure 11. Reverse Recovery Charge vs. Forward Current Rate of Change





Figure 10. Reverse Recovery Time vs. Forward Current Rate of Change

- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.
